**Quarterly Report pursuant to Immigration and Nationality Act**

This report is from October 1, 2025 through December 31, 2025

**O.C.G.A 42-4-16**

At least quarterly, an individual in a supervisory role at a county jail or municipal detention facility shall prepare and post on the public website of the local jurisdiction where his or her jail or detention facility is located, a report for his or her jail or detention facility which includes the following information for the most recent quarter:

- (1) The total number of inmates booked into the county jail or municipal detention facility;
- (2) The total number of inquiries made to the Law Enforcement Support Center (LESC) of the United States Department of Homeland Security or any other federal agency inquiring relating to the immigration status or prior arrests of foreign-born inmates;
- (3) The total number of responses received for requests made by the county jail or municipal detention facility pursuant to paragraph (2) of this subsection;
- (4) The total number of responses as provided for in paragraph (3) of this subsection that indicated a foreign-born inmate of the county jail or municipal detention facility is an illegal alien as such term is defined in Code Section 42-4-14;
- (5) The number of immigration detainers issued by the United States Immigration and Customs Enforcement Division of the Department of Homeland Security for prisoners in the county jail or municipal detention facility; and
- (6) A sworn affidavit signed by the individual in a supervisory role at the county jail or municipal detention facility verifying compliance with Code Section 42-4-14 and all other applicable law

**O.C.G.A 42-1-11.4**

The commissioner shall, on the official public website used by the department, publish a report of aggregate date on the immigration status, offenses, and home countries of inmates who are confined under the authority of the department who are not citizens of the United States and to whom the United States Immigration and Customs Enforcement Division of the Department of Homeland Security has issued immigration detainer notices as such term is defined in Code Section 42-1-11.5. Each report shall include the total number of inmates who are not citizens of the United States; provided, however, that any inmates who are citizens of both the United States and one or more of the countries shall be designated as such as a separate category. Such report shall be first published on October 1, 2024, and every 90 days thereafter; provided, however, that if the ninetieth day falls on a state holiday or Saturday or Sunday, the such report shall be published the next business day.
